


Anonymous Healthcare Scholarship Recipient - DYLAN HARSHMAN






ASSET ALLOCATION AND INVESTMENT PERFORMANCE

ASSET ALLOCATION


as of June 30, 2021

\$4,438,320 as of June 30, 2021


TOTAL ENDOWMENT MARKET VALUE




ENDOWMENT SNAPSHOT

The Foundation currently has 60 endowed funds that donors have designated for particular purposes such as scholarships, program support and capital improvements. To effectively manage these funds, the Foundation combines the assets into an endowment pool with each endowment fund owning shares in the pool. The Foundation follows a distribution policy based on a rate of 3% of a 3-year rolling average of the market value of the endowments as measured on December 31 of each year.

FOUNDATION YEAR IN REVIEW

Student Assistance: Since March of 2020 the Foundation office, in partnership with student services, awarded over \$850,000 to students through scholarships (\$220,000); internet assistance (\$166,000), Cares Act (\$463,000) and emergency requests (\$18,000).

Shoulder to the Wheel Organization Award: The Foundation received this award from the Rock Falls Area Chamber in recognition of the efforts made by the Foundation and its dedicated army of volunteers and staff to support students with resources to successfully navigate their way through both school and life.

Special Visit: On Monday, April 19, 2021 First Lady Dr. Jill Biden visited Sauk Valley Community College. She was joined by Education Secretary Dr. Miguel Cardona, Governor J.B. Pritzker, Congresswoman Cheri Bustos, and other special guests. Dr. Biden was given a tour of the facility and provided with demonstrations of SVCC's Manufacturing and Health Professions.

She demonstrated motivation to reach her personal and education goals both academically and through her involvement in student and volunteer organizations.

Days of Giving – From May 4-6, 2021, a total of 200 donors and sponsors gave \$27,000 to support SVCC Days of Giving. Gifts to the campaign support scholarships, academic departments, student life programs, and athletics.

SVCC Impact Program – In June of 2021 the Foundation received a \$1 million gift to support the SVCC Impact Program. This largest one-time gift from an anonymous donor in Whiteside county will fund pilot programs in the Fulton and Prophetstown school districts beginning in the Fall of 2025. Through this gift, the donor hopes to inspire and motivate others to give to the program that college and regional leaders anticipate will transform lives and help propel the region into a period of increased growth and stability.
